

- 4. The programs have been granted accreditation for 3 years. **Government Engineering College, West Hill P O, Kozhikode, Pin 673005, Kerala** should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
- 5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to Government Engineering College, West Hill P O, Kozhikode, Pin 673005, Kerala as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. - 9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication giving reasons for the same and by paying the requisite fee.
